DECLARATION OF OWNERSHIP

- c. Please provide the names and current addresses of members of the board of directors, registered owners/offices of the company or share-holders if this information is not provided in the business registration.

Please indicate whether any member of the company board or directors or registered owners currently holds elective or appointive office in a municipal or central government position or in the executive body of a political party. *[Note: a positive answer may require an amendment to the license.]*
